#### SUNRIVER ANGLERS HOSTS JOEL LAFOLLETTE



On November 19, the Sunriver Anglers Club will present what promises to be a great program featuring Oregon angler and manager of Kaufmann's Streamborn Fly Shop in Tigard, Joel LaFollette.

Joel learned the art of fly-fishing in the cool pine forest along the banks of the Metolius River at the age of 9. His grandfather brought him there to learn to fly fish on the same waters his grandfather had. Since that first outing, Joel has fished the wilds of Venezuela, Belize, Mexico the Bahamas and Christmas Island for Bonefish, Tarpon, Permit, Trevalley and other saltwater fish. He has traveled the Northeast for Brook Trout, Browns and Stripers. In the

South, he's tried his luck with Redfish and giant Tarpon, but the giant Steelhead of northern British Columbia have found a special place in his heart. These great fish will be the focus of his program on the  $19^{th}$ .

Joel's adventurous career has included stints as a commercial fisherman, professional photographer and race car driving instructor! Now, as the retail manager for Kaufmann's, Joel still guides occasionally on the Deschutes and hosts fishing trips around the globe for Kaufmann's.

Joel is highly regarded for his exquisite flies and likes to sign off with the notation "Steelhead are too noble a fish to be caught with an ugly fly".

# Fascinating Fishing Facts:

<u>Fastest Fish</u> A group at Florida's Long Key Fishing Camp came up with a simple method for accurately measurning a fish's swimming speed. A fish is hooked. It makes a run. You measure how much line the fish took off the spool in a certain number of seconds and you can calculate the fish's speed.

The fastest fish in these speed trials, perhaps the fastest in the world, was a sailfish that took out 300 feet of line in three seconds, a velocity of 68 mph. That's zero to 60 in 2.6 seconds!

#### New Business:

<u>Board Members and Officers for 2010:</u> The Nominating Committee has recommended the following Officers and Board Members for 2010.

Officers: Alan Stout, President; Chuck Devine, Vice President; Gary Gehlert, Secretary; Jack McDonnell, Treasurer.

<u>Two Year Directors</u>: Gary Gehlert, Alan Stout, Doug Vakoc, Marv Yoshinaka, Allen Jones, Mark Baldwin, Herm Meister, plus one to be nominated later.

One Year Directors: Chuck Devine, Dave Jendro, Jack McDonnell, Mal Murphy, Bruce Stendal, Pete Gustavson, Paul Oles, Ed Tank. Mal Murphy moved and Dave Jendro seconded a motion to submit the above nominees to the general membership at the Nov. 19th meeting for approval. It was further stipulated that one additional 2 Year Director may be submitted for later approval. The motion carried unanimously.

<u>USFS request for \$1000 for tree placement</u>: The USFS has requested that we provide a \$1000 matching grant so that they will have sufficient funds to complete a stream restoration project on the Deschutes River. The project would be concentrated at the north end of Sunriver and include the river banks on both sides of the river. Dennis Patterson moved and Pete Gustavson seconded a motion to include the \$1000 in our 2010 budget. The motion passed unanimously.

<u>Christmas Dinner</u>: Dec. 9, 2009. The cost this year will be \$55.00 per plate. That includes two bottles of wine per table. It was tentatively agreed to give two comp tickets to each area fly shop, four to Lodge staff, and to the hatchery staff. Pete Gustavson agreed to call on the new Dick's Sporting Goods store for a donation. We need physical items that can auctioned at the dinner. Jack McDonnell asked that all items be given to him no later than Dec. 5th.

November Outing: November 17 on the Crooked River. Since that is before the next General Meeting a reminder will be sent out to members. It was suggested that experienced members share information about fly selection and fishing techniques in the reminder.

<u>SROA Board Report</u>: Pete Gustavson would like to begin sharing a short report each month about The Board's priorities and projects that could effect our club.

<u>Future Programs</u>: Nov. 19th; Joe Lafollette on steelhead fishing in British Columbia. Jan. 21st; Wayne Johnson on the Owyhee and the South Boise. Feb. 18th; Mike Lawson.

SROA Bank Restoration: The project is on hold until the State sets a date for its archaeological review.

<u>DRC meeting</u>: DRC has reached a tentative agreement with two irrigation districts that could significantly improve the winter water flow in the upper Deschutes. DRC has been invited to make a short presentation at the Christmas Dinner.

The November outing will be on the Crooked River on <u>Tuesday</u>, <u>November 17th</u>. This is a week earlier than usual because the regular outing day  $(4^{th}$  Tuesday of the month) falls in Thanksgiving week this month. We will meet at the Sunriver Marketplace (North Store) at 9:00 AM.

The Crooked has been fishing very well lately. Early action is on nymphs, with a Blue Wing Olive hatch coming off in the 11:00-11:30 time frame. Club members who have fished the river recently have done extremely well with any good BWO imitation. The Whitefish spawning will probably have begun by the  $17^{th}$ , so be sure to have some egg imitations in your box.

#### Whirling Disease Mini-Workshop:

The threat of whirling disease being introduced to the Upper Deschutes with the reintroduction of anadromous fish above the Pelton Round Butte dam complex has been revisited in the technical news during recent weeks. This exposure of an important issue needs discussion and a mini-workshop on the issue has been scheduled.

We're fortunate to have four of the most knowledgeable speakers on the topic agree to present their views at a panel presentation followed by questions and answers. I hope you can attend - it's a serious and timely topic with many facets.
